Motion was approved with a vote of 5 - 0.

The sheriff's office, along with other law enforcement entities will step up seatbelt enforcement over the Thanksgiving holiday.

The council reviewed the engineering services contract from Snyder & Associates for the design and construction phases of the wastewater treatment facility. This contract will cover three years of work with the next major step being the completion of construction plans and specifications that is due next December (2017). Significant discussion was held about liability insurance for a project of this size. A representative from Snyder will report back at the December meeting regarding options for additional levels of coverage. Sobiech-Munson moved to approve the contract with the correction of "Alliant Energy" as the utility within the city and with the option to increase the insurance coverage pending approval from the City Attorney. Ransom seconded. Motion was approved with a vote of 5-0.

May moved to hold the third reading and adopt Ordinance 267, setting water rates. The connection charge remains the same at \$12.16 and the charge per 100 cubic feet increased \$0.02 from \$4.53 to \$4.55. Erickson seconded. Roll call votes were as follows: Ayes – May, Erickson, Ransom, Kahler, and Sobiech-Munson. Nays – None.

Erickson moved to hold the third reading and adopt Ordinance 268, setting sewer rates. Due to the impending wastewater treatment facility, the connection charge will be increased from \$10.50 to \$21.00 and the charge per 100 cubic feet will increase from \$3.83 to \$4.50. Kahler seconded. Roll call votes were as follows: Ayes – Erickson, Kahler, May, Sobiech-Munson, and Ransom. Nays – None.

The council reviewed the proposed amendments for the FY 17 budget. A public hearing is scheduled for the next meeting on December 12 at 7:30 pm.

The city has been working with the new owners of the mobile home park to parcel off three small sections of land. Two will be sold to adjacent land owners and the third will be given back to the city for street right of way. May moved to approve Resolution 8 (2016-17) waiving subdivision requirements for parcel N & P. Sobiech-Munson seconded. Motion was approved with a vote of 5-0.

The city has been working a lot with storm water both in the city and the entities affected as it runs downstream. Sobiech-Munson moved to approve Resolution 9 (2016-17) approving the Fourmile Creek Watershed master plan. Erickson seconded. Motion was approved with a vote of 5-0.

Kahler moved to approve the liquor license for B-Fabulous BBQ. The business will be catering during the holidays and plans to open a sit-down restaurant in February. Sobiech-Munson seconded. Motion was approved with a vote of 5-0.

The council reviewed a recommendation from the Revitalization Incentive Fund Committee to approve the request made by B-Fabulous BBQ for a \$100,000 zero-interest economic development loan for renovations to the building they purchased at 600 Linn. The loan will be repaid over 10 years. Kahler moved to approve the loan. May seconded. Motion was approved with a vote of 5-0.

The annual Tax Increment Finance report is due to the State on December  $1^{st}$ . The council reviewed the report and Erickson moved to approve. Ransom seconded. Motion was approved with a vote of 5-0. Staff discussed that one business in the TIF program has received back less than half of the amount projected in the development agreement due to a significantly higher base value than anticipated. The council discussed extending the payback period so that the business will receive an amount closer, but not to exceed the original estimate. The council will revisit this issue at the December meeting.

City staff has met with developers for 2 proposed residential areas within city limits. Council discussed these areas and specific items to consider as plat design work continues. Street width, large lot frontages and water drainage are key issues.

May moved to adjourn the meeting at 9:46.	Kahler seconded.	Meeting adjourned.
