Mayor Kahler opened the public hearing for the rezoning of a portion of property ID 13-31-100-115 from Agriculture to M1-Light Industrial at 7:36pm. Davies reported no written or verbal questions or concerns have been received. Planning and Zoning has approved. There was discussion on size and location. Having no questions or comments from the public, and no further discussion for the Council, Mayor Kahler closed the public hearing at 7:42pm. Motion was made by May, seconded by Birdsall to hold the 1st Reading of Ordinance #284: Change in Zoning. Roll call vote: Ayes: May, Birdsall, Erickson, and Howell. Nays: none.

Mayor Kahler opened the public hearing for Specs and Plans for Waste Water Treatment Facility at 7:45pm. Davies reported no written or verbal questions or concerns have been received. Having no questions or comments from the public, and no further discussion for the Council, Mayor Kahler closed the public hearing at 7:46pm. Motion was made by Erickson, seconded by Howell, to approve Resolution #12 (2020-2021): Adopting plans and specifications, opinion of probable costs, for of contract for Waste Water Treatment Facility – Slater, Iowa. Motion approved with vote 4-0.

Motion was made by May, seconded by Birdsall, hold the 1st reading of Ordinance #285: Limiting number of dogs to 5 and cats to 5 for each property within Slater City limits. Roll call vote: Ayes: May, Birdsall, Howell, and Erickson. Nays: none.

Council discussed budget for FY2022 and reviewed the proposed Max Property Tax Levy. Motion was made by Erickson, seconded by May, to approve Resolution #13 (2020-2021): Setting Public Hearing date for proposed Max Property Tax Levy. Motion approved with a vote of 4-0.

Motion was made by May, seconded by Birdsall, to approve the FY2022 contract with City of Kelley for Administrative Duties. There are no changes in the contract from last year. Motion approved with a vote of 4-0.

Gogerty reported Library is back to in person storm time with sign up slots in order to limit number of participants. They organized a cookie plate "delivery" in place of Friday soup and song programs. There is a Christmas Story Walk on Main Street that has been quite popular and will try to plan others for the year.

EMS reported on November calls. A trainee has almost completed training. This will bring Slater EMS up to 9 members. Reminder: EMS meetings have moved to the 2nd Thursday of each month.
