Alliant reported that is a nationwide shortage of transformers so the project currently underway within Slater City limits has come to a complete stop until transformers come in – most likely till summer of 2023.

A Slater resident had questions regarding street sweeping, and snow ordinance. He also spoke on concerns of plugged storm drains, painting of curbs and storm drain areas; and weeds growing in curbs and streets.

Motion was made by May, seconded by Newman, to approve Resolution #14 (2022-2023): Pay Application #13 to Story Construction for the WWTF. Motion approved with a vote of 5-0.

Motion was made by May, seconded by Howell, to approve Resolution #15 (2022-2023): Pay Application #14 to Story Construction for the WWTF. Motion approved with a vote of 5-0.

Motion was made by Newman, seconded by May, to waive the 2^{nd} reading and have the 3^{rd} / Final reading for Ordinance #294: No parking on Main Street from Story Street to Tama St from 2:00 am to 6:00am daily." Roll Call vote: Ayes: Newman, May, Erickson, Birdsall, and Howell. Nays: none

Mayor Kahler opened the public hearing for FY 2023 Budget Amendment #1 at 7:59pm. Davies reviewed the changes which are for the Zero Interest Loan program; and reported no written or verbal questions or comments have been received at Slater City Hall. Having no questions from those present and no further discussion Mayor Kahler closed the public hearing at 8:00pm. Motion was made by Erickson, seconded by Birdsall, to approve Resolution #16 (2022-2023): FY 2023 Budget Amendment #1. Motion approved with a vote of 5-0.

Motion was made by Newman, seconded by Birdsall, to approve Resolution #17 (2022-2023): Approving and adopting a Revenue Purpose Statement for the use of Revenues from Electric and Natural Gas Franchise Fees. Motion approved with a vote of 5-0.

Motion was made by Birdsall, seconded by Howell, to set a public hearing date for December 12, 2022 @ the regularly scheduled Council meeting starting at 7:30pm for the Alliant Franchise renewal. Motion approved with a vote of 5-0.

Motion was made by Newman, seconded by Birdsall, to approve the Fireworks permit for Christmas on Main Event – December 4th at approximately 5:00 pm. Motion approved with a vote of 5-0.

Motion was made by Birdsall, seconded by Howell, to approve a new Part Time public works employee – Ryan Newell starting at \$15.50 per hour. Motion approved with a vote of 5-0.

Motion was made by Erickson, seconded by May, to approve the Library 2023 calendar as presented. Motion approved with a vote of 5-0.

Council reviewed and discussed potential Capital Improvement Projects which included, but not limited to upgrading equipment, new water meters, lining sewer mains to reduce infiltration, sump pump collection system, street paving, park development and improvements, pool improvements, copier for City Hall, 1st/Fire Building, Community Center/Library, sidewalks, and EMS monitor.

Davies reported the new Website is up and running. Wow, check it out, it looks great and is user friendly. Residents can now sign up for text message and emails notices from the City of Slater.

Library Director, Jennifer Gogerty, reported \$30,000 was raised through the Gather Event on Oct 15th; they are working on accreditation, which is due in February. As part of this an updated 5 year plan is required and they will be doing a phone survey; and the Library will once again participate in Christmas on Main – December 4th.

EMS Chief Fleenor reported calls for October; there are continued discussions with Fire on new building ideas; volunteers need to be trained on pagers vs phones; and 4 members attended continuing Education classes this month.

Estrem reported the tower to improve the paging system will be install November 15th; the replacement slide has been installed at Nelson Park.

Motion was made by Erickson, seconded by Birdsall, to go into closed session pursuant to Iowa Code sec 21.5(1)(c) to discuss potential litigation or where litigation is imminent where its disclosure would be likely to prejudice or disadvantage the position of the governmental body in that litigation in order to review items dealing with the construction of the Waste Water Treatment Facility and sewer expansion to Trailside Development. Motion approved with a vote of 5-0. Closed session began at 9:05pm once all public had left the building.

Open Session reconvened at 9:47pm. Roll call/Attendance: Erickson, May, Newman, Birdsall, and Howell. Absent: None.

Davies was director to have letters will be sent from Attorney regarding those items discussed in Closed Session.

Motion by Newman, seconded by May, to adjourn the meeting at 9:48pm. All Ayes.
