A property owner spoke his concerns for water and sewer rates.

Mayor Kahler opened the public hearing for Alliant Franchise Renewal for Natural Gas and Electric to Include 1% Franchise fee at 7:45pm. Davies reported no written or verbal questions or comments have been received regarding this topic. Kahler explained the 1% Franchise fee will replace the 1% Local option sales tax on Alliant billing for those properties within Slater City limits. These dollars will then come directly to the City of Slater instead of being collected as Local Option Sales Tax (LOST) and dispersed to all entities in Story County. Having no comments from those present and no further discussion, Kahler closed the public hearing at 7:46 pm. Kahler then began consideration and discussion of Ordinance #295: AN ORDINANCE REPEALING ORDINANCE NO. 230 AND GRANTING TO INTERSTATE POWER AND LIGHT COMPANY, ITS SUCCESSORS AND ASSIGNS, A NON-EXCLUSIVE TWENTY-FIVE YEAR FRANCHISE TO ERECT, CONSTRUCT, RECONSTRUCT, MAINTAIN, AND OPERATE PLANT AND SYSTEMS FOR THE DISTRIBUTION OF NATURAL GAS IN THE CITY OF SLATER, IOWA AND TO SELL, DISTRIBUTE, AND SUPPLY NATURAL GAS TO SAID CITY AND ITS INHABITANTS, AND REQUIRING SAID COMPANY TO PAY A

Council and Mayor asked him multiple times to stop interrupting. Council member May apologized to the Mayor, the rest of Council, and staff for any wasted time, but this disruption has been going on for many years and can NOT continue. May left the meeting at 7:50pm.
