Mayor Kahler read the proclamation recognizing September 17 through 23<sup>rd</sup> as Constitution week.

Sheriff's office reported mostly quiet in Slater.

Resolution #4: Engagement letter with Ahlers and Cooney for URA for Trailside Development was tabled in order to gather more information.

Council discussed Trick or Treating. It was agreed due to COVID-19 that residents should make that decision on an individual bases. If a household would like to participate in Trick or Treating October 31 from 6pm -8pm they should practice social distancing, wear a mask, and have a light on to welcome trick or treaters. If you do not want to participate simply keep lights off.

Council reviewed Ordinance #281: Amending use of Fire Works. Many options were discussed. Motion was made by May to have the 1<sup>st</sup> reading of Ordinance #281: amending use of Fire Works. Motion died for a lack of a 2<sup>nd</sup>. No changes will be made at this time.

Motion was made by Erickson, seconded by Birdsall, to approve Resolution #6(2020-2021): Approval of FY2020 Road Use Report. Motion approved with a vote of 5-0.

Council discussed prorating the base water/sewer rates for residents who move in/out or sell a property in the middle of the meter reading cycle. An ordinance to make this change will be presented at future Council meetings.

Motion was made by May, seconded by Newman to set a public hearing date for FY 2020-2021 Budget Amendment #1 for the next regularly scheduled Council meeting - Oct 12, 2020. Motion approved with a vote of 5-0.

EMS reported on August calls and training.

Gogerty reported the Library had 125 participants in the final summer program that was held at Nelson park in order to practice safe distancing. The Fall reading program has started. Reading programs are being held in the park. The building committee will be meeting at the end of September to resume fundraising activities.

Public Works is still working on cleaning up tree debris in the parks.

Motion by May, seconded by Howell to adjourn the meeting at 9:08 P.M.
