41.12 FIREWORKS USE

1. Definition. (shall remain the same) The term “fireworks” includes any explosive composition, or combination of explosive substances, or articles prepared for the purpose of producing a visible or audible effect by combustion, explosion, deflagration or detonation, and specifically includes blank cartridges, firecrackers, torpedoes, skyrockets, roman candles, or other fireworks of like construction and any firework containing any explosive or flammable compound, or other device containing any explosive substance.

2. Regulations. A person shall not use or explode consumer fireworks on days other than July 3rd, 4th, and 5th and Fridays and Saturdays from June 1st to July 8th and only during the hours of 12:00 pm (noon) to 10:00 pm on those specified days from June 1st to the Saturday after 4th of July; December 30th of each year from the hours of 4:00 pm to 10:00 pm; and December 31st of each year starting at 4:00 pm through January 1st ending at 12:30 am.

A person shall not use, explode or discharge Consumer fireworks on real property other than that person’s real property or on the real property of a person who has consented to the use of consumer firework on that property. A person shall not use, explode or discharge Consumer fireworks on publicly owned property, included but not limited to, City streets and parks, except as specifically authorized by permit issued pursuant to the City of Slater Code. A person that chooses to use, explode or discharge Consumer fireworks on their property shall have responsibility to clean up all debris created by the fireworks.

The City may, upon application in writing, grant a permit for the display of fireworks by a City agency, fair associations, amusement parks and other organizations or groups of individuals approved by City authorities when such fireworks display will be handled by a competent, trained, and insured operator. No permit shall be granted hereunder unless the operator or sponsoring organization has filed proof of such training and insurance.

Any person in violation of this Ordinance shall be fined \$150.00 per incident.

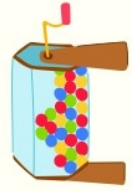

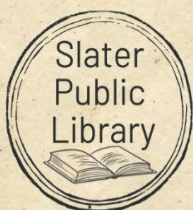

Slater EMS: Neighbors Helping Neighbors in Emergencies

Slater EMS is proud to serve our community with a dedicated team of 10 volunteer responders, including paramedics, Advanced EMTs, EMTs, and registered nurses. As a state-licensed provisional EMS agency, we provide critical emergency medical care—ranging from Emergency Medical Technician (EMT) to Advanced EMT level of care—depending on which trained volunteers are available at the time of the call. While we are a non-transport service, we partner closely with Mary Greeley Medical Center to ensure timely and seamless patient transport when needed.

Each year, Slater EMS responds to an average of 168 emergency 911 calls, with the majority of these calls related to falls in the home or community. Our team covers Slater, Sheldahl, and rural portions of Story and Polk Counties. Every one of our volunteers serves in this capacity in addition to their full-time careers, driven by a shared commitment to helping our neighbors in times of need. We are grateful for the ongoing support of our community and hope to continue building awareness about the vital role local EMS plays in public safety. Your continued encouragement helps keep this life-saving mission going strong.

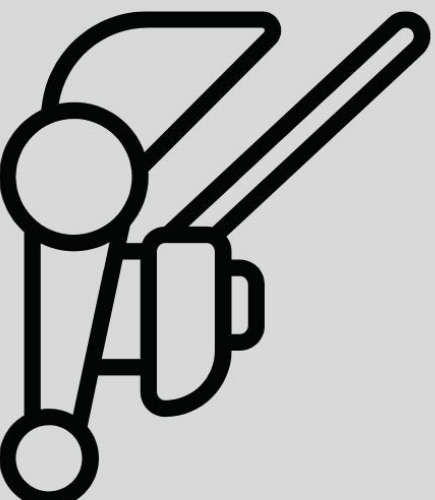
Golf Cart Rules

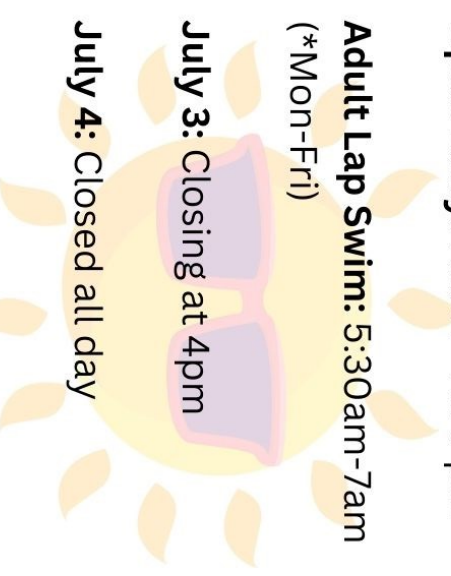

DEFINITIONS

- Maximum Contaminant Level (MCL) – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- Maximum Contaminant Level Goal (MCLG) -- The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- ppb -- parts per billion.
- ppm -- parts per million.
- pCi/L – picocuries per liter
- N/A – Not applicable
- ND -- Not detected
- RAA – Running Annual Average
- Treatment Technique (TT) – A required process intended to reduce the level of a contaminant in drinking water.
- Action Level (AL) – The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- Maximum Residual Disinfectant Level Goal (MRDLG) - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- Maximum Residual Disinfectant Level (MRDL) - The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- SGL – Single Sample Result
- RTCR – Revised Total Coliform Rule
- NTU – Nephelometric Turbidity Units

GENERAL INFORMATION

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water posed a health risk. More information about contaminants or potential health effects can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by *Cryptosporidium* and other microbial contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. SLATER MUNI WATER DEPT is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. This water supply obtains its water from the buried sand and gravel of the Buried Sand and Gravel aquifer. The Buried Sand and Gravel aquifer was determined to have low susceptibility to contamination because the characteristics of the aquifer and overlying materials provide natural protection from contaminants at the land surface. The Buried Sand and Gravel wells will have low susceptibility to surface contaminants such as leaking underground storage tanks, contaminant spills, and excess fertilizer application. A detailed evaluation of your source water was completed by the Iowa Department of Natural Resources, and is available from the Water Operator at 515-228-3339.
